LISE-1 Introduction to International Studies: Theories and Methods [5 ECTS]

Lecturer: Bent Boel

Course description

This course is an introduction to basic concepts and analytical tools useful for the study and

understanding of International Studies as well as to some major issues in international politics. The students should purchase:

Course objectives:

Knowledge of:

- basic theories and methods within the field of international studies, including knowledge of international studies as an interdisciplinary field and of the disciplines hereof (politics, culture, economics etc.)
- basic concepts within the field of international studies
- the main target areas of international studies, including the emergence of the international community and the conditions for the co-existence of nations and regions, particularly the main social and political problems and challenges of the international society, international social and political institutions and international human rights.

Skills in:

- communicating knowledge on the above-mentioned disciplines in a clear, structured and comprehensible manner.

Competences in:

- using basic theoretical and empirical knowledge for analyzing and working on a concrete issue within the field of international studies.

Assessment

The course is assessed on the basis of an exam portfolio, the precise contents of which will be determined at the start of the semester. A specific grade will be awarded in accordance with the Danish 7-point grading scale.

LISE-1 20th and 21st Century Cultural and Social History [5 ECTS]

GRADED AS 'PASSED OR FAILED': NO SPECIFIC GRADE WILL BE AWARDED

Lecturer: Ben Dorfman

Course description

- This course is intended to take students through some of the important themes in 20th and 21st century
- The intention is to provide a historical background not only for the first semester project, but the study as a whole. The course will address a wide array of social movements, political events, global conflicts and cultural phenomena important for the contemporary world, as well as a general knowledge of the latter part of modern history.

The class will be broken into lectures and discussion sessions. There will be a theme question for each lecture which the lecturer will address. For each lecture, students will have been expected to prepare their own one page answer to the week's question. Students will also be expected to present their answers and get critique in short version in discussion sessions.

In terms of readings, students are expected to use the course text as a "research text." I.e., rather than assigned readings for each week, students should explore the book to formulate an answer to the week's question. Students should also cite where in the text they've gotten the information for their answers.

Assessment

The course is pass/fail. In order to *pass* the course, students must come to class and submit their one page answers to the thematic question for each week. They must also participate in the group presentations organized around the questions in discussion session. There is an 80% attendance/active participation requirement for the course. Students can meet that by accumulating 22 total points out of the following categories (in week 1, there is only attendance; no write-up):

Lecture attendance: 9 points (1 per lecture attended)

Submission of weekly write-up: 8 points (1 per write-up submitted)

Discussion session attendance: 4 points (1 point per session attended)

Participation in discussion session presentation: 6 points

Students not accumulating 22 points will have to pass a maximum 8 page take-home essay on a topic of the instructor's choosing. Students NOT having passed this course are not allowed to participate in the project exam. If students will have difficulties in meeting any of the course requirements, they're asked to speak with the instructor immediately.

Students must have passed this course before they are allowed to stand for their project exam.

The course is a 5 ECTS course. The project examination, related to both this course as well as "Introduction to International Studies: Theories and Methods," is 10 ECTS.

LISE-1 INTERNATIONAL STUDIES PROJECT [10 ECTS]

NO SEPARATE COURSE

Project description and pre-requisites

The module consists of lecturer-supervised problem-oriented project work within the field of International Studies. It is a requirement for completion of the module that the '20th and 21st Century Cultural and Social History' course has been completed and that the portfolio for the 'Introduction to International Studies: Theories and Methods' (SIS-1) course has been submitted (see above).

Project objectives

Students should gain knowledge about a delimited topic within the field of International Studies on the basis of the project. The topic must derive from the two project courses above. Furthermore, students should acquire skills in analysing and understanding cultural, social and political phenomena in relation to modern and current development processes as well as skills in applying fundamental knowledge about important political, cultural and social events and trends in western and global history of the 20th and 21st centuries.

Finally, students should obtain competencies in:

- working independently and in groups,
- handling relevant theories and methods for the analysis of a delimited problem within International Studies, and
- presenting ideas, arguments and research results within International Studies in an appropriate academic form, both orally and in writing.

Assessment

The project is assessed on the basis of the project report prepared by the student(s) and the oral defense of the project. Max. 15 pages per student in the project group, alternatively max. 20 pages for an individual project report. Time allotted for the oral defense: 30 minutes per student. The emphasis in the assessment is on the written report. A specific grade will be awarded in accordance with the Danish 7-point grading scale.

Supervision: A professor will be allocated as supervisor during the project period.

LISE-3 International Relations: Theories and Methods [5 ECTS]

Lecturer: Bent Boel

Course description

This course is an introduction to theories and methods useful for the study and understanding of International Relations as well as to some major issues in international politics. The students should purchase: John Baylis, Steve Smith and Patricia Owens (eds.), The Globalization of World Politics. An Introduction to International Relations, Oxford 2014 (6th edition).

Assessment

Written take-home exam on a lecturer-defined topic. A specific grade is awarded.

LISE-3 The History of International Relations in the 20th and 21st Century [5 ECTS]

GRADED AS 'PASSED OR FAILED': NO SPECIFIC GRADE WILL BE AWARDED

Lecturer: Søren Dosenrode etc.

Course description

Welcome to this course on 'the History of International Relations in the 20th and 21st Century'. This course will introduce you to central developments in international relations both at a global level (such as the 1. World War, the 2. World War, the Cold War, spread of a liberal world order), but also at a regional level (Asia, Africa, North- and South America, Europe, Russia).

The teachers reflect the concept of a regional approach in so far as they are either specialists within the region's history or specialists and natives of the region they teach about.

Please note that a series of discussions is part of this module and that active participation is a condition for passing the exam. Sandro Nickel will guide you through the discussions.

Course material (kursusmateriale) may be found in three forms: as reference to book; as uploaded under the individual lectures under 'Slides, noter m.m.'; or as approachable via the link indicated on this page. Make sure to check 'Slides, noter m.m.' even if there is a link indicated, as the lecturer may have added several pieces of literature.

Assessment

The course is assessed as Passed/Failed on the basis of active participation in 80% of the course sessions, with no specific grade awarded. Active participation is defined as reading of the course literature, attending minimum 80% of the lectures, and contributing to the discussion sessions through oral presentations and active participation in discussions.

Alternative assessment

If students do not meet the assessment requirements above, they must instead submit a take-home assignment on a lecturer-based topic. Minimum 6 pages, maximum 8 pages. The take-home assignment is assessed as Passed/Failed, with no specific grade being awarded.

LISE-3 INTERNATIONAL RELATIONS PROJECT [10 ECTS]

NO SEPARATE COURSE

Project description and pre-requisites

The module consists of lecturer-supervised problem-oriented project work within the field of International Relations. It is a requirement for completion of the module that 'The History of International Relations in the 20th and 21st Century' course (see above) has been completed and that the take-home assignment in extension of the 'International Relations: Theories and Methods' course has been submitted (see above).

Project objectives

Students should gain knowledge about a delimited topic within the field of International Relations on the basis of the project. The topic must derive from the two project courses above.

Furthermore, students should acquire skills in:

- formulating a scientifically relevant problem within International Relations,
- applying relevant theories and methods for the analysis of the formulated problem
- communicating ideas, arguments and research results within complex problems in International Relations in a convincing, well-argued and precisely phrased academic form, both in writing and orally.

Finally, students should obtain competencies in:

- applying relevant theories and methods for the analysis of complex problems within
- International Relations, communicating ideas, arguments and research results within International Relations.

Assessment

The project is assessed on the basis of the project report prepared by the student(s) and the oral defense of the project. Max. 15 pages per student in the project group, alternatively max. 20 pages for an individual project report. Time allotted for the oral defense: 30 minutes per student. The emphasis in the assessment is on the written report. A specific grade will be awarded in accordance with the Danish 7-point grading scale.

Supervision

A professor will be allocated as supervisor during the project period.

LISE-3 Introduction to Political Philosophy [5 ECTS]

Lecturer: Ben Dorfman

Course description

This course will take students through some of the major debates and concepts in the history of political thought with the goal of expanding students' vocabularies as political thinkers, social

thinkers and ethical thinkers. The course will use the Universal Declaration of Human Rights as its starting point, ask students to take a position on the ideas embedded therein, and then discuss how their view of different portions of the document transforms (or doesn't) as they move through the various readings and concepts of the course. The point is to acquaint students with classical traditions of political thought and provide them understanding of the intellectual background of political philosophical debates playing out today.

Exam

The course exam is technically a maximum 8 page take-home assignment. However, portfolio style, students will be asked to prepare at least one page of writing each week regarding the authors they've looked at, and how those authors have or have not effected their view of the Universal Declaration. Completion of the weekly one page assignment will be incorporated into the final grade. Students who attend all classes and make an honest attempt at answering all questions are guaranteed at least a 4 (D) in the class (this will be checked each class [exceptions will of course be made for medical emergencies or other unexpected events]). Students who do NOT attend all classes and complete the assignments on time without a valid excuse will be allowed a maximum grade of 10 (B). Final grades will be assigned based on an assessment of the final compiled assignment, due October 30.

Format

The class will largely be lecture. However, after verifying the completion of weekly assignments, the class will begin by inviting students to share their views and, in some cases, calling on students to express their opinion. After discussion, the class will then move to lectures and comments from the course instructor.

LISE-5 Introduction to Sociology [5 ECTS]

Lecturer: Lotte Bloksgaard & Stine Thiedemann Faber

Course description

In this course, you will be introduced to the discipline of sociology. You will learn about the development of sociology as a field of research and learn about various theoretical perspectives and methodological approaches central to the study of society.

Content and learning objectives (from Curriculum):

- Knowledge and understanding of:
- basic key theories and concepts within sociology
- basic themes and issues in classic sociology
- methods in contemporary research within sociology
- the most significant contribution of sociology to the understanding of the contemporary globalized world.

Skills in:

- understanding social change processes in the light of relevant sociological theory
- communicating knowledge on social issues in the context of sociological research.

Competences in:

using sociological theory as a basis for analyzing and understanding concrete social issues.

Assessment

The course is assessed on the basis of a lecturer-defined take-home assignment. Maximum 8 pages, with one page being defined as 2400 characters including spaces.

A specific grade is awarded.

ORGANIZATIONAL STUDIES project combination

LISE-5 Organizational Studies: Theories and Methods [5 ECTS]

Lecturer: Kirsten Jæger

Course description

The module Organizational studies: theories and methods has two objectives:

- Providing the student with knowledge of organizational theory and of different research approaches to the study of organizations
- In combination with the course, International organizations, laying the foundation for writing a project in the area of organizational studies

Organization is a pervasive aspect of modern society. Few of our everyday practices are uninfluenced by some form of organization: going to the university, shopping or being engaged in political work are all activities involving interaction with organizations. Many organizational scholars argue that organizations play an increasing role in modern society and that a contemporary citizen accomplishes most of his/her daily routines by way of some form of organizational participation. This implies that for many phenomena that we subject to research as students or scholars, considering organizational aspects is relevant. In order to understand the way organizations function and operate, we need to ask to ask such questions as: what kind of organization is this, how is it built up, and how are the internal power relations formed? Which cultural assumptions dominate in the organization, and how do its members communicate and interact in order to keep the organization functioning. And importantly: how does the organization interact with its social, political and cultural environment? But first and foremost we must try to find a response to the basic question: what is an organization – how do we understand this phenomenon. Organizational theory provides us with a wide range of different answers to this question, and the primary goal of the module is to present and discuss various answers. The course is premised on the notion that organizations are found everywhere: from transnational corporations and institutions to local informal gatherings united by a shared concern, grappling to form some kind of identifiable collective. It will introduce classic organizational theories focusing on formal structures and hierarchies as well as contemporary approaches taking an interest in how organizations are accomplished through organizational participants' daily routines and practices.

Assessment

The course is assessed on the basis of an exam portfolio, the required contents of which is decided at the start of the semester. A specific grade is awarded.

LISE-5 International Organizations [5 ECTS]

Lecturer: Helene Pristed Nielsen

Course description

The course evolves around questions relating to civil society, private and public international organizations, including non-governmental organizations, social movements and their significance to the international society. We will be discussing a number of theoretical perspectives as well as empirical cases during sessions, and I plan a high degree of student involvement in various types of group work and discussions throughout the course.

The very first thing you should do is to go to the bookstore and buy Robert Putnam's book, Bowling Alone. The collapse and revival of American community, New York: Simon and Schuster, 2001.

You should read chapter 3 before the first session (+ 1 & 2 if you have time).

Please note that students are expected to be involved in several group-based tasks during sessions, many of which require online access. So could those of you who have the option, please bring your laptops to sessions, so that we have as many computers as possible online during our discussions?

The course is assessed on the basis of a lecturer-defined take-home assignment. A specific grade is awarded.

LISE-5 Organizational Studies Project [10 ECTS]

NO SEPARATE COURSE

Assessment

The project is assessed on the basis of the written project report plus the oral defense. The project report should be max. 15 pages per student in the project group and max. 20 pages in the event of individual projects. One page is defined as 2400 characters including spaces.

Registration for the project requires:

- registration for both of the two LISE-5 courses (Organizational Studies: Theories and Methods and International Organizations)
- submission of both the exam portfolio for Organizational Studies: Theories and Methods and the take-home assignment for International Organizations

Supervision

A professor will be allocated as supervisor during the project period.

Please also note that the oral defense is scheduled for January 2016. Consequently, students should register for this project if they are prepared to undertake the oral defense in January 2016.

A specific grade is awarded.

Courses offered by the Culture, Communication and Globalization (CCG) program

CCG - Culture, Communication and Globalization: The Master's program in CULTURE, COMMUNICATION & GLOBALIZATION accepts admission to the following courses for international

students enrolled in International Cultural Studies. PLEASE NOTE THAT CCG EXAMS IN EXTENSION OF CCG COURSES ARE ASSESSED AT GRADUATE LEVEL, MEANING 7TH- SEMESTER/4TH-YEAR UNIVERSITY LEVEL. Students interested in CCG courses are advised to check out the CCG website in addition to the information on courses below.

CCG: The core courses immediately below are compulsory for all students opting for a CCG PROJECT assessment and may be taken individually by students opting for topic paper assessment.

CCG COURSE REGISTRATION REQUIREMENTS AND ASSESSMENT: Assessment: 5 ECTS/2½ US credit points awarded for a topic study. (A maximum of two CCG courses may be assessed by a topic study, whether students attend AAU for one or two semesters).

Alternative assessment: 20 ECTS/10 US credit points awarded for a project exam. To register for the project, two core courses are compulsory, and two additional courses must be taken from one of the streams of CCG courses. This means that the maximum CCG course registration is for four courses assessed by a project plus oral exam, plus two individual CCG courses each assessed by a topic exam, for an overall total of 30 ECTS.

All courses are 5 ECTS/2½ US credit points, assessed by topic papers. Max. two CCG courses may each be assessed by topic papers.

Project: 20 ECTS/10 US credits.

One topic study: 5 ECTS/2½ US credits

Core courses

Core Course 1: Globalization

[5 ECTS if assessed by a topic study. Max. two CCG courses may be assessed by a topic study.] Lecturers: Robert C. Thomsen etc.

Course description

This course is a joint, stream-shared course of the 7th semester of the CCG. Together with 'Managing Multiculturalism, with PBL/Project Writing' it forms the two core courses of the semester which, along with two optional stream courses, make up the basis of the module 'Global Processes' and thus for the semester project.

Core Course 2: Managing Multiculturalism, incl. PBL (project-based learning)/project writing

[5 ECTS if assessed by a topic study. Max. two CCG courses may be assessed by a topic study.] Lecturers: Helene Pristed Nielsen etc.

Course description

Welcome to this joint (all streams) course on 'Managing Multiculturalism, with PBL and Project Writing'. Together with the course 'Globalization' it makes up the core joint courses this semester. It is on the basis of these and two selective courses that you will be writing your semester project. This course will be dealing with multiculturalism as a political, economic, organisational and institutional reality that has set in motion a series of changes and debates, and we will be discussing the merits and relevance of various types of solutions offered to 'manage multiculturalism'.

The course is organised as a series of lectures presenting theoretical approaches to how to respond to multiculturalism, giving also empirical examples. Interspersed with the lectures, the course consists of a number workshop sessions, in which you will be gaining hands-on experience with how to devise useful problem formulations, project and research designs - all intended to make you ready for project writing when the course ends in early October.

The purpose of the course is thus two-fold: a) to make you knowledgable about different theories and issues relating to multicultural challenges, and b) to prepare you for semester project writing.

Course description

On this page you can find various materials relating to the course. However, please also

remember to familiarize yourselves with the curriculum which explains the content of the programme, various exams etc. (see the enclosed attachment). The course is an integral part of the module on global processes and the key topic is 'consumption and communication' within a globalized context.

The course introduces a broad range of perspectives and issues prevalent in contemporary consumption studies. The principal aim is to promote students' reflection on prevailing theories and topics, as well as to develop ideas for project work by discussing how consumer theories can be applied in different thematic and empirical fields. We discuss consumer behavior as closely related to particular social, cultural and historical contexts reflecting main sociological and anthropological approaches to the field of cultural consumption studies. During the course you will learn to identify differences between theories and to reflect on the different interpretations, implications and explanations of consumer behavior that they offer. In addition to this, the course has a particular focus on the understanding of cultural differences in a globalized world and on working with 'culture' as an academic concept. Finally, most consumer theory is developed in (affluent) Western Europe and the US. We will discuss possible implications of this and include some examples of consumer studies from other parts of the world (Russia/Eastern Europe, China). The first half of the course will focus on the main sociological and anthropological theories on consumption and consumers, whereas the latter half will provide empirical/thematic examples of consumer studies.

Intercultural Competence in an Organisational Context

Course description

The course introduces the student to intercultural competence as a theoretical concept and relates the discussion of the complexity of the culture concept to intercultural competence, particularly in an organisational setting.

The main objective of the course is to give the student insight into the practical implications of intercultural competence on both an individual and an organizational level. How does intercultural competence express itself in practice - in the organizational culture, in human resource management, knowledge management, and in corporate and societal structures and programs?

How can a person - in practice - contribute to the building of intercultural competence in organizations?

Working methods: lectures as well as group and plenary discussions based on real-life examples and cases drawn from public and private sector organizations. In addition, two videos will be shown.

The United States and Global Politics

[5 ECTS if assessed by a topic study. Max. two CCG courses may be assessed by a topic study.] Lecturer: Bent Boel

Course description

This course will focus on America's role in the world. We will examine the postwar history of US foreign policy, discuss approaches to the study of the United States' international role, various way to categorize US foreign policy traditions as well as a number of key contemporary issues: unilateralism and multilateralism in US foreign policy, the American "empire", the "War Against Terror", the US role in the Middle East, transatlantic relations... Students will be expected to participate actively in class and make at least one oral presentation. Social Movements and Global Democracy

[5 ECTS if assessed by a topic study. Max. two CCG courses may be assessed by a topic study.] Lecturer: Lise Rolandsen Agustin etc.

Course description

This course will focus on the role of social movements in the pursuits of democracy, justice and equality in the world. Social movements can be understood as forms of collective action which aim to obtain substantial social change in a particular field (civil rights; the environment; gender, etc.). They are usually also understood as being in conflict with the establishment of actors, institutions, ideas and norms within their field of interest. Today social movements are claimed to work in an increasingly global political, social and economic context. We can here think of the Occupy Wall Street movement which has emerged not only in the USA but also elsewhere in the world or of the gendered and feminist aspects of the revolutionary moments and reactionary processes which have occurred in Egypt recently and which have led to reactions also in other parts of the Arab world. These observations urge us to consider what we mean by democracy from global, transnational and local perspectives and what is old and what is new about these issues?

Using different social movements as a starting point the course therefore addresses global, historical and theoretical perspectives upon social movements, putting these in the context of contemporary debates on global democracy and global civil society. This includes amongst others discussions on the globalization of accountability, the use of international law by activists and the role of global and transnational institutions in the contemporary struggles of social movements.

Stream D: International Migration & Ethnic Relations

Disturbing Landscapes: Migration, Difference and Social Hierarchies

[5 ECTS if assessed by a topic study. Max. two CCG courses may be assessed by a topic study.] Lecturers: Peter Hervik etc.

Course description

In contemporary society difference and diversity are perceived in terms of challenging developments, often leading to disharmony, and dis-homogeneity, social unrest and "ethnic" conflict. We learn that diversity needs to be managed, accommodated and mediated in order not

to disrupt historically settled "social cohesion" and national unity, by giving rise to internal struggles and discord. In the recent decade, multiculturalism and the 'limits to tolerance' have been amply debated from many sides: while on the one side positive emphasis is given to the enrichment coming from different social, cultural, ethnic, religious and sexual orientations, on the other side diversity is portrayed as irreconcilable, conflictual and threatening the integrity of the existing 'status quo' (variously defined in terms of social cohesion, national culture, identity, etc.).

This course aims at approaching the complex and interrelated forms of diversity in society and to provide analytical, methodological, theoretical and conceptual tools that can help the student to study and understand how diversity is or can be defined, constructed, structured, interpreted and managed. Also, during the lessons we will strive to dig down into the mechanisms that often are used to 'boil down' complexities and oversimplify and hierarchise differences and diversity. By means of various studies and perspectives (historical, anthropological, sociological, geographical, politological, linguistic) we will approach the mechanisms that build and manage difference, paying attention to the implications of these approaches, on the urban space, in media, in discourse and in other concrete settings.

Course description

"Management and Organizational Theory" covers different perspectives on organizational theory and organizational communication. We will primarily deal with the systems perspective, the constitutional perspective, critical power approaches and cultural approaches. Moreover, we will discuss specific challenges to organizations both from a theoretical and practical perspective: the challenge of globalization and diversity, the challenge of new technologies and the challenge of organizational change. The course has an interactive design, combining lectures, discussions, case studies and ethnographic fieldwork which call for active participation on the part of the student. Accordingly, it is important that you have read the assigned text in advance. Another important part of your work is to spend some time (30-60 min) in an organization and document what you see by taking notes, pictures, etc (assignment 1). Additionally, you analyse one or two documents from or about the same organization (assignment 2). You present your findings in two reports and relate them to an organizational theory.

In this module, students work with basic theories and practical methods in regard to the creation of sculptures and sculptural installations and the design of physical artefacts as an aesthetic manifestation. Using materiality as a point of departure, students work with basic principles of form, tactility, structure, composition and artistic expression. Students experiment with a variety of materials and basic technologies in connection with the design and creation of physical artefacts. Students work theoretically and experimentally with a variety of formal, static and dynamic principles, and contexts of use.

Students will work with principles of creation for time-based artifacts, and the experience of artifacts expressing temporal, spatial, and affective transitions. A variety of audio/visual technologies and engineered solutions will be tested and applied in the creation of products, artifacts and installations in the project unit, including mechanical and electronic alternatives of creating and controlling movement, position in space and autonomous motion.

During the semester, students work theoretically and experimentally with projects that challenge their creative and technologies skills and produce artistic effects focused on performative interaction between humans and machines.

- central theories within narratology with special focus on narratives in interactive settings
- methods for the creation of narrative installations
- central theories within (inter/re-active) dramaturgy and performance design
- theories and methods of combining physical and digitally enhanced spaces
- artistic and technological strategies within performance design and performative events
- manuscripts and storyboards as central creation methods of narrative media installations
- artistic and academic methods of collaborations with external partners

Examination 15

An internal combined written and oral examination in Module 15 "Narratives and Interaction".

The examination will take the form of a conversation between the student, the examiner and another internal examiner on the basis of the project report prepared by the student(s), which may be in the form of a report or portfolio as well as the product created by the student. The project exam will also address other content from the module courses.

Form of examination: b)

Number of pages: the written work must not exceed 10 pages per student (15 pages in the case of individual reports).

Duration of examination: 20 minutes per student and 10 minutes for assessment and communication of grades per group, however, the duration of the examination is maximum 2 hours.

Evaluation

Grading according to the 7-point scale.

Proportional weighting: An aggregate grade is awarded for the artefact, the written and oral performances.

The assessment results in an individual grade.

Credits: 15 ECTS

The written report, the product and the oral examination should demonstrate that the student has fulfilled the objectives outlined above.
